Greetings and best wishes from Michael Stephens, President of the Algonquin Valley Branch (AVB). It is mid-June 2018 as I prepare this update on our Branch activities.

Branch Annual Meeting – This year's Branch Annual Meeting (BAM) was held at the Royal Canadian Legion in Petawawa on April 4.

Renewing recruitment efforts at Canadian Nuclear Laboratories – As I noted at the BAM, I think it is important that the Branch renews new member recruitment efforts at Canadian Nuclear Laboratories (CNL) staff at the Chalk River Laboratories. This is particularly important now. As of September CNL staff will no longer be able to acquire further qualifying time of service for their

Public Service Superannuation Plan pensions. Many staff may be thinking of retiring now or in the near future, and be quite receptive to consider joining Federal Retirees. Please take any opportunity you have to speak to CNL staff over the coming months. If each AVB member got one person to join the Branch, our membership would double. It would also strengthen us for the longer term, which may be more challenging.

Do we have your email address? - The Association and AVB Executive do not have email addresses for a substantial number of members. AVB covers a vast area, and sending information to all members by post is very expensive. Being able to send information to you by email makes it possible for us to give you much more timely details on upcoming events. Transitioning from military to civilian life Last year AVB hosted one of a dozen Town
Halls held near Canadian Forces Bases
across Canada. Military retirees' views were
collected on how well the processes are
working for them to make the transition from
military to civilian life after retirement. A report
on what was heard was issued in the spring,
was presented to the appropriate
governmental bodies in Ottawa, and will guide
future action by the Association. Details are

Appeal of Federal Court decision on the Public Service Health Care Plan (PSHCP) -The Association is appealing the court decision rejecting our challenge of the government's action to change the fraction we contribute to cover PSHCP costs. Association response to Bill C-27 - In 2016 the federal government October introduced Bill C-27 (An Act to Amend the Pension Benefits Standards Act). The bill would make possible the introduction of "target benefit" pension plans for federallyregulated and Crown corporation employers. The AVB report in the Summer 2017 issue of SAGE included the letter we wrote to our MP. Cheryl Gallant, summarizing the Association's numerous concerns with Bill C-27. government has still not advanced the bill beyond first reading in the House of Commons, but it is very likely that the idea will resurface sooner or later.

PLEASE ASK YOUR SURVIVORS TO INFORM AVB AFTER YOU PASS AWAY

For members who have dues directly deducted from their pension payments (i.e., DDS), the government notifies the Association when deductions have stopped, but the Privacy Act prevents the government from notifying the Association that the member has died. (Deductions may have stopped for other reasons.) For members who pay dues each year, it is up to their survivors to let the Association know of their death. Mail sent by our National Office is returned to sender, and it is left to the branch to track down the reason.
