With 23 Branch members in attendance, the Vice-President, V. Hulley declared that the meeting quorum requirement (2x9 executive members +5) was met with 24 members in attendance..

The Vice-President invited comments on the draft minutes of the last AVB BAM, held at by Zoom on April 14, 2021. No changes to the minutes were proposed.

- 5. Reports
- a. President

The Past-President, Paul Ballantyne remarked on behalf of the President, Ken McDonald absent for being in contact with covid-19 that the following activities were initiated, organized or participated in:

Retention and recruitment of members - are difficult processes. Our capability and capacity to engage our members is hampered by the large geographic area of the branch. Using the post office to inform members costs over \$1500 for each attempt. CNL employees are no longer contributing to PSSA pensions and are no longer a source of members; Garrison Petawawa is now the single largest source. In addition to the advocacy offered, there are many benefits to being a member by taking advantage of deals offered by preferred partners such as travel and medical insurance through Medoc, Johnson insurance for home and vehicles, and cheap phones through Simply Connect. The Ottawa Branch is receptive to having us attend their zoom presentations.

Communication - with our members is difficult, postage is an expensive option, we only have 40% of our members email addresses, and we lack contact information for 3% of our membership.

Finances - are deep in the black for without being able to hold in-person activities, we are underspending our budgets and have had to send back excess funds

Other items of interest and concern

Optometrists – still an issue of coverage for seniors as negotiations continue. Phoenix payments – still affecting members as the aftermath of botched payment of wages continues to be sorted out. The National Office has helpful resources. Personal Meetings – with the pandemic we have not been able to meet in person; this BAM is the first of hopefully better opportunities to engage our members Relationship with National Office - excellent; they are responsive to our inquiries PSHCP – negotiations are still ongoing to improve health benefits – we get better benefits but it will come at a higher cost. The key item driving up our premiums is the over-subscription of drugs

Outreach – is a process to connect with politicians. It is an ongoing exercise and will continue into the coming provincial election

b. Membership

Membership Secretary, Mary ter Huurne, presented AVB membership report for 2021–2022. Membership attrition happens with death, departure from the region, or withdrawal: increases are through transfers and public service retirees from

- 1,931 members (down ~200 in two years)
- 1,244 memberships
 - 687 double memberships
 - 557 single memberships
- Concerns:
 - · 3% of members have no mailing address on file
 - · 46% of memberships have no email address on file
- Positive news:
 - New members in 2021 trending up 89 new members in 2021 compared to 208 new members in previous five (5) year period
- · The members live in
 - · Deep River (25%)
 - Pembroke (25%)
 - · Petawawa (19%)
 - Petawawa (19%)
 - Renfrew (5%)
 - · Chalk River, Eganville and unknown (3% each)
 - Ontario and other provinces (17%).

c. Treasurer

The Treasurer, Julie Mallory, reviewed the finances

- Excess funds of \$32,131 were returned to National Office in 2021. These funds had resulted from under spending in previous years and reductions to our Reserved Equities as voted on at our 2020-21 BAM.
- No changes to current Reserves have been proposed for 2022. Reserves will remain as they are currently reflected at \$29,500.

The Reviewed Financial Statements for the year 2021 showing a Loss of (\$25,190.41) was presented as established by the return of excess funds. See **Attachment 1**

Motion 2022 – 03 by Judith Clothier and seconded by Mary ter Hurrne, that the financial statements for the year 2021 be accepted as presented. **Carried.**

The Year 2022 Budget showing a balanced budget with \$14,600 of revenues and expenses was presented.

Julie Mallory thanked Dave Raman for reviewing the 2021 Financials of the AVB. His efforts were well appreciated. Julie Mallory called for a volunteer to review the 2022 financials.

Motion 2022 – 05 by Paul Fehrenbach and seconded by Peter Wegner to have Dave Raman review the 2022 AVB Financial Statements. **Carried**

d. Communications

In the past year, a Communications Committee under the direction of Vickie Hulley was formed to examine and improve the means to communicate with members.

Highlights:

- The Branch Communications Committee was formed in July 2021.
- First order of business was to create a Terms of Reference for the Committee.
 This Terms of Reference was approved by the AVB Executive on September 14, 2021.
- The Committee has prepared a series of information articles that will be published in the local newspapers in the near future.
- Produced and coordinated advertising for Zoom programs and the BAM.
