on Thursday, April 13, 2023

Branch Annual Meeting (BAM)

The President, V. Hulley, welcomed everyone to the Algonquin Valley Branch Annual Meeting (BAM) held in-person at the Royal Canadian Legion, Petawawa. Following the formal meeting, M. ter Huurne gave a presentation: "The Way: My Camino in Spain". The President called the BAM to order at 1:12 pm and presented the 2022 - 2023 slate of members of the AVB Executive:

V. Hulley thanked the executive members for their support during 2022 -2023 year.

1. Establish Quorum

The President, V. Hulley, declared that the meeting quorum requirement (2x5 executive members +5) was met with 45 members in attendance.

2. Approval of the Agenda

The President invited additions to the proposed agenda.

Motion 2023 - 01: Moved by N. Gleason and seconded by M. ter Huurne, that the proposed agenda be adopted. **Carried**

3. Approval of 2022 BAM Draft Minutes

The President invited comments on the draft minutes of the last AVB BAM, held on April 13, 2022. No changes to the minutes were proposed.

Motion 2023 - 02: Moved by C. Langlais and seconded by R. Christie, that the draft minutes of the 2022 AVB BAM be approved. **Carried**

4. Business arising from the minutes

There were no follow-up actions from the last BAM.

5. Report

a. President

V. Hulley, remarked that N. Gleason took over Advocacy position and her experience added great value to the executive and to the branch. The following activities were initiated, organized or participated in:

- Petawawa Showcase in April 2022
- Annual Picnic last August was the first in-person event since before the pandemic
- Two in-person workshops were organized: “Your Health” (Nov) and “Computer Fraud and Scam” (Feb)
- AVB reports were submitted in Fall 2022 and Spring 2023 issues of SAGE respectfully
- AVB representative, W. Turner, attended the 2022 Annual Members Meeting

b. Membership

Membership Secretary, M. ter Huurne, presented AVB membership report for 2022– 2023. Membership attrition happens with death, departure from the region, or withdrawal; increases are through transfers and public service retirees from Canadian Armed Forces, Royal Canadian Mounted Police, Judges and Federal Government employees. In summary:

- 1,920 members (down 11 since last year)
- 1,236 memberships
 - 685 double memberships
 - 551 single memberships
- Concerns:
 - 3% of members have no mailing address on file
 - 42% of memberships have no email address on file
- Positive news:
 - New members in 2021 trending up – 89 new members in 2021 compared to 208 new members in previous five (5) year period
- The members live in
 - Deep River (25%)
 - Pembroke (26%)
 - Petawawa (18%)
 - Renfrew (6%)
 - Chalk River, Eganville and unknown (3% each)
 - Ontario and other provinces (17%).

c. Advocacy

N. Gleason stated that an effective advocacy brings awareness to priorities, creates public support and influences public policy.

- Advocacy Info Night was held on December 1, 2022 at Best Western Hotel in Pembroke. A speaker from the National Office gave a presentation on:
 - Advocacy Wins
 - Advocacy Priorities
 - Importance of Advocacy
- N. Gleason met with Cheryl Gallant MP on December 19, 2022 to discuss:
 - C. Gallant's support for NAFR's Recommendations for the upcoming 2023 federal budget.
 - Commit to long-term care standards and a national senior's strategy
 - Invest in and implement pharmacare
 - Support caregivers
 - Action on equitable outcomes for veterans
 - Resolve Phoenix issues fairly by the end of 2023
 - Improve retirement security

Federal Retirees' recommendations are clear: the 2023 federal budget is the time to improve retirement security and health care for Canadians.

- N. Gleason also met with John Yakabuski MPP on January 25, 2023 to secure commitment in transforming older adult care.
 - 80% of the COVID deaths in the 1st wave occurred in long term care facilities.
 - Older adults are the fastest growing segment of our population
 - A study by CSA Group reported, that by 2030 Ontario will need an additional 199,000 long term beds.

Federal Retirees is advocating for governments at all levels to work together to reform older adult care and implement national standards for long-term and home care as part of a comprehensive national seniors' strategy.

- Upcoming Advocacy Information Night with a presentation by National Association of Federal Retirees (Amy Baldry) is scheduled for May 25, 2023 at Towne Suites Place, 160 Town Centre Blvd, Petawawa, ON.

d. Treasurer

The Treasurer, J. Mallory, reviewed the finances

- Excess funds of \$6,905 were returned to National Office in 2022. These funds had resulted from under spending in 2021.
- Underspending continued in 2022 with operating expenses of \$7,589 versus revenues of \$14,848. The 3-year average spends calculation used to determine the allowable unreserved equity has been updated to include 2018, 2019 & 2022 with indexing factors applied.
- No changes to our Reserved Equity Accounts are being proposed at this time

The Reviewed Financial Statement for the year 2022 showing Earnings of \$353.57 was presented. See **Attachment 1**

Motion 2023 – 03: by J. Mallory and seconded by Judith Cloutier, that the financial statements for the year 2022 showing a surplus of \$6,905.24 be accepted as presented. **Carried.**

Year 2023 Budget showing a balanced budget with \$15,100 of revenues and expenses was presented.

Motion 2023 – 04: by J. Mallory and seconded by Paul Ballantyne, to accept the balanced budget as presented. **Carried**

J. Mallory reviewed the AVB Reserves Template totalling \$29,500. See **Attachment 2.**

Motion 2023 – 05: by L. Buckley and seconded by B. Mallory, to approve the Reserves Template as presented. **Carried**

J. Mallory thanked D. Raman for reviewing the 2022 Financials of the AVB. His efforts were much appreciated. J. Mallory called for volunteer to review the 2023 financials. D. Raman volunteered and was accepted by acclamation.

e. By-laws

At the Annual Members Meeting in 2022, the Association's Regulations 4.3 and 5.1 were updated. To comply with the new wording of the national regulations, Section 9.6 has been updated while subsections 9.6.1, 9.6.2 and 9.6.3 were reviewed and subsequently removed since there is no longer such a reserve in the by-laws and the reference was removed from the revised Regulation 4.3.

- Proposed amendment to the local By-laws states:

"9.6 Reserve Funds

The Branch may establish and maintain reserve funds in accordance with the Association's Regulations. The Branch board has the authority to create, change, or remove such reserves and must present a report on the status of all branch reserves at each annual general meeting as part of the presentation of the Branch's financial statements."

Motion 2023 – 06: by D. Raman, seconded by P. Wegner to accept updated Algonquin Valley Branch By-laws Section 9.6 as presented. **Carried**

f. Communications

The branch Communications Committee under the direction of Vickie Hulley

- Continued to operate in 2022/2023
- The Committee wrote additional information articles that will be published in the local newspapers in the near future
- Wrote and submitted two inserts to Sage Magazine

6. Weighted Voting System

N. Gleason explained that, currently NAFR branches have one vote each. The proposal is to increase number of votes of branches based on membership. The issue is the imbalance with respect to branch and their weight in concert with coalitions.

A weighted voting system is a decision-making procedure in which the participants have varying numbers of votes.

Examples:

- Shareholder elections
- Some legislative bodies
- International Monetary Fund

This issue is under review for the upcoming Ontario District Meeting to consider the democratic imbalance and consider reforms to change the weight and increase the voice of the majority of Branches in decisions that affect NAFR.

Members were asked by N. Gleason the following question: “Are you satisfied the proposed voting model represents your vote as a member of the Association?” The result was pretty much split in the middle.

7. Election of Officers

The president, V. Hulley, presented a Mission statement and Vision for the National Association of Federal Retirees

Mission: “To significantly improve the quality and security of retirement for our members and all Canadians through advocacy and the provision of services” and

Vision: “All Canadians enjoy dignity and security in retirement.”

- Effective September 1, 2023 Ontario will be changing eye exam eligibility for seniors:
 - People aged 65 and older will be covered for one eye exam every 18 months, instead of one a year
